5. Academic Entrance Assessment and Student Interview

- The Academic Entrance Assessment will be scheduled (*late spring/early summer*). Testing fee is payable on or before the scheduled entrance assessment.
- Student Interview with Principal will be scheduled for 5th - 12th grade students

6. Notice of Acceptance and official placement on the student roster.

Note: An interview with the parent/guardian may be required prior to official acceptance.

Family Stewardship Agreement

- Each family is responsible for either 20 hours of documented volunteer hours per school year or may choose to pay a lump sum of \$350.
- The Stewardship year for the 2019-2020 school year will start after May 16, 2019, and run through May 15, 2020. This allows families to volunteer time during the summer.
- Stewardship hours will be invoiced in May. All volunteer hours turned into the office by May 15th will be credited from the total amount prior to this billing. Any hours turned in after May 15th may be held until the next school year.

Non-Discrimination Policy

Financial Responsibility:

- Registration fees are **not** refundable.
- Annual Technology fee per student is payable with the **first** tuition payment.
- We understand that we must set up and maintain an account with FACTS Management prior to Enrollment.
- We understand that tuition must be paid in one of the following ways: *Choose one*
 - Payment in full on or before June 25, 2019 according to FACTS Management agreement.
 - Monthly payment plan according to FACTS Management agreement.
- There is a service fee for all NSF returned items.
- If payments are **not** made per agreement:
 - Financial Assistance (if applicable) may be withdrawn.
 - My child may be withdrawn on the first of the month if the previous month's financial obligations have not been met and if arrangements have not been made with the administration.
 - A late fee of \$25 may be assessed.
 - I understand official report cards and/or diplomas will be held, and requests for official transcripts or transfer of records may not be honored for students whose accounts are past due.
 - If collections action are necessary, I agree to pay collection fees and reasonable attorney fees. The venue would be Thurston County.
- There will be a replacement cost charged for any lost and/or damaged textbooks.
- I have read, understand and agree to comply with the Family Stewardship Agreement.
